

SAN GABRIEL VALLEY JR. ALL-AMERICAN FOOTBALL CONFERENCE INC.

SEASON PLAYER VERIFICATION

San Gabriel Valley Jr. All-American Football Conference (SGVJAAFC) requires that all Franchises request proper documentation prior to enrolling a new player in their Franchise. To ensure that all Franchises have recruited from within their defined SGVJAAFC Boundary or an "Open Territory" all new players will be required to submit a season player verification form and proper documentation prior to commencing season play.

RESIDENCY ELIGIBILITY REQUIREMENTS

SGVJAAFC determines the actual geographic boundaries within a Franchise where they shall be eligible to enroll players. These boundaries are shown on a map and must be used when enrolling players. Players will be eligible to play with that Franchise only if they reside within the boundaries or an "open territory", as approved by SGVJAAFC, or a valid cut contract has been issued by their Home Franchise. Failure to provide the proper documentation will deem the player ineligible for season play.

A PLAYER WILL BE DEEMED TO RESIDE WITHIN THE FRANCHISE BOUNDARIES or OPEN TERRITORY IF:

- A. His/her parents are living together and are residing within such Franchise OR "Open Territory" boundaries, OR;
- B. Either of the player's parents (or his/her court-appointed legal guardian) reside within such boundaries. It is unacceptable if a parent moves into a Franchise's boundaries for the purpose of qualifying for season play. As detailed later in these rules, the penalty for violation of this rule may, in San Gabriel Valley Jr. All American's discretion, result in the disqualification of a player, team or entire Franchise from regular season and/or post season play (if a split household: residency will be based on custody split and/or school record address). "Residence," "reside" and "residing" refers to a place of bona fide continuous habitation. A place of residence once established shall not be considered changed unless the parents, parent or guardian makes a bona fide change of residence. Residence shall be established and supported by documents containing the full residence which includes parent(s) or guardian(s) name, street address, city, state and zip code information, dated or in force between November 1, 2023 (previous year) and June 30, 2024 (current year), from one or more documents from each of the three Groups outlined below:

NOTE: Example – Three documents from the same Group (utility bill, cable bill, and bank statement) constitute only ONE document.
Any documents submitted as proof of residence must show customary usage or consumption to demonstrate bona fide continuous habitation as determined by San Gabriel Valley Jr. All-American Football Conference in its sole discretion.

Sensitive Information: SGVJAAFC recognizes the sensitive nature of personal information such as account numbers, social security numbers, etc. All sensitive information on documents submitted for verification may be blacked out, with the exception of the name and address. SGVJAAFC will not keep any submitted documentation, all paperwork will be returned to the team official upon completion of the verification process.

Only Exception to the above Residency requirements:

Player was issued a valid cut contract by their "Home" Franchise which can be documented on a current or past "Player Contract" which are on file with the Conference Office.
